

# 2005 NJ State Wrestling Championships

The best double-elimination-wrestle-back-to-first-place (Finals Only) state championship tournament in New Jersey (NJ residents only). To qualify for the finals, you must place 1<sup>st</sup> – 4<sup>th</sup> in one of the 2 qualifiers listed below. Buena qualifier: max wrestlers is 400. Kenilworth qualifier: max wrestlers is 350. All 8 place winners (4/weight/division/qualifier) must pay a \$15.00 advancement fee at the qualifier in order to wrestle in the Finals. **Selected state place winners are eligible for selection to SJWA Team NJ for the VAC/SJWA MS National Challenge Duals on Feb 18-20, 2005 at the Wildwoods Convention Center. All Intermediate place winners are eligible and 65 & 70 pound Juniors are eligible for the 65 & 70 lb slots.** Younger wrestlers who want to be eligible for selection MUST wrestle up to the appropriate age division in order to qualify for selection. - No HS wrestlers permitted (9 – 12) • Wrestlers must have been born after 12/31/89 •
  - Must be legal resident of NJ, and may only wrestle in 1 weight & 1 division •
- Birth certificates required if challenged, subject to disqualification if not presented by both parties in 10 minutes •
- Minimum 30 minute interval between matches • Bantams: 1-1-1 • Midgets/Junior/Intermediates: 1-1 ½ - 1 ½ •
- Admission to all tournaments: Adults - \$5.00, Children - \$3.00, under 5 yrs old free •

 Bantam: 1 – 1 – 1 Midget, Junior and Intermediate: 1 – 1 ½ - 1 ½  
 Overtime – Scholastic rules Headgear mandatory  
 No high school wrestlers NJ certified officials only  
 NJ residents **ONLY** may wrestle Advancement fee of \$15 due at qualifier to go to final tournament
