- Minimum 30 minute interval between matches • Bantams: 1-1-1 • Midgets/Junior/Intermediates: 1-1 ½ - 1 ½ •
- Admission to all tournaments: Adults - \$5.00, Children - \$3.00, under 5 yrs old free •
